- Two letters of recommendation – one from a business person, community leader or JA classroom volunteer and one from a teacher or school administrator.

ELIGIBILITY CRITERIA

- Applicants must be eligible to graduate during the current school year from a Dane County high school.
- Applicants must have participated in at least one Junior Achievement high school classroom program.
- Applicants must be eligible for admission to an accredited technical school or college where the student will pursue an Associate or Bachelor's Degree in business, finance, or banking.

SELECTION OF RECIPIENTS

Scholarship recipients are selected on the basis of their application to a committee appointed by Junior Achievement of Wisconsin in Dane County. Financial need is not considered.

The applicant will be notified of the award by **May 31, 2020**.
